Our regular pricing plans are per domain or subdomain and have a 'soft limit' of 300.000 page views per month per domain. (with an allowed overuse of 25% in 2 consecutive months) But for clients, with large numbers of domains, subdomains and / or traffic we offer tailored plans to best accommodate your requirements.

Regular pricing plans (traffic within 'soft limit')

- Basic monthly €9,- ex VAT / month / (sub-)domain
- Basic annually €99,- ex VAT / year / (sub-)domain (inc.1 month of free usage)
- Plus monthly €19,- ex VAT / month / (sub-)domain (inc. TCF 2.2 support)
- Plus annually €209,- ex VAT / year / (sub-)domain (inc. 1 month of free usage & TCF 2.2 support)

Consent Banner and Consent Mode implementation steps



Self serve available

Get started in 5 easy steps

- Register your account at <https://app.cookiefirst.com/register>
- Add a domain to your account to start scanning your website
- In the banner settings enable Google Consent Mode and either set the [defaults over the CookieFirst platform](#) (gtag.js) or use our [GTM template](#) to setup Google Consent Mode for your website.
- Go to the embed code settings and copy the cookie banner embed code (gtag.js) or the domain api key (GTM).
- (gtag.js) add the embed code directly after the <head> tag in your website above any Google tags.
- (GTM) Add the domain api key in the template and publish the container.

To be able to use Consent Mode and our cookie banner you either need to be able to change code on your website OR know how use Google Tag Manager in order to configure Consent Mode for your website.



You can finish the process within 5 minutes to setup a banner and implement Consent Mode.
