- Deploy the Ketch Smart Tag (a piece of javascript code) on your website or digital property.
- 4. In your Ketch instance, connect your Google tag manager container or enable Google Consent mode for Google tags.
- 5. (Optional) Map your tags to purposes of data processing.
- 6. (Optional) Initiate a sync between Ketch & GTM to push your changes to your container.
